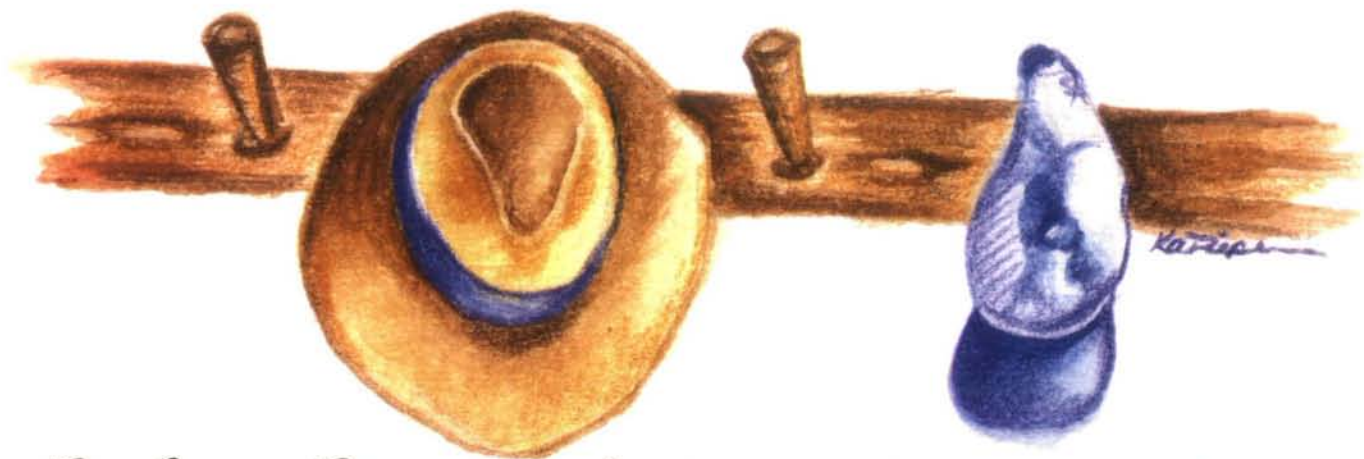

have made in my life!*

Every active alumna has her own unique story to tell about why she has remained involved in Pi Beta Phi. We hear the words "Pi Phi is a lifetime experience and a lifetime opportunity." But what makes membership in Pi Phi different from other women's organizations? My opinion is there is one important ingredient—the personal touch.

As a young alumna, I moved to an area that was organizing an alumnae club. My previous perception of alumnae involvement was that it was something you did when you were much older—at least 45 or 50 years old. Therefore each time I was contacted, I had many "good reasons" why I could not participate. Then one day, my doorbell rang, and I was surprised to find the club president standing there with a Pi Phi yearbook for me. After that expression of friendship, I felt that I should show the courtesy of at least attending a club meeting, and as they say ... the rest is history.

The second president of the new club gave some good advice in the closing remarks of her term—"When it becomes your time to serve as president, I hope you will accept the challenge and the opportunity, you will never regret it." This statement continues to be true today, 35 years later, and applies to all opportunities for involvement with Pi Beta Phi, from serving on a committee and hosting a meeting, to accepting a position as a province officer, director or member of Grand Council.

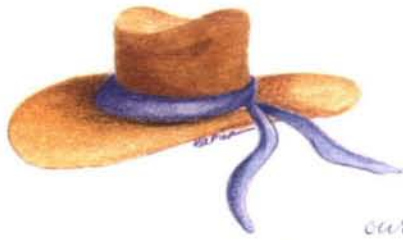
There are so many ways that Pi Beta Phi can enhance your life. For anyone who has placed a

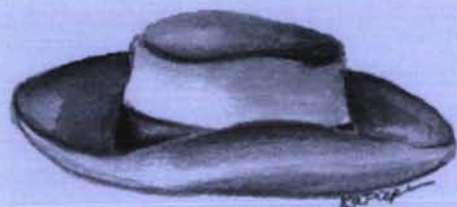
## *"Toward 2000 Together"*

# News from Arrowmont

## Michigan Beta Artist-in-Residence



For Michigan Beta Johanna Paas, the path to Arrowmont took a few detours. Although she enrolled in elementary education at the University of Michigan in 1991, she soon got hooked on art history. She switched gears from education to art, with a concentration in ceramics.

In her last semester, Johanna's college path took another turn—she switched her concentration from ceramics to printmaking. She found that she enjoyed making prints on her ceramic pieces with a slab roller. Someone suggested she take a printmaking course. "I really liked ceramics, but after taking the printmaking class, I just didn't have as much passion for clay as I did working with the press."

In 1995, Johanna graduated cum laude with a bachelor's of fine arts degree. In 1997, Johanna received an art education certificate from Eastern Michigan University. She spent the next four months student teaching and realized she didn't have much time to pursue her own art. Applying to be an Arrowmont assistant seemed the logical thing to do. She was accepted into the

assistantship program and spent seven weeks at Arrowmont last summer.

The path led her to apply for the 11-month Artist-in-Residence program, to which she was accepted. The program gives pre-professional, self-directed artists time and space to develop a major body of work in a creative community environment of students and visiting faculty. Residents are also encouraged to participate in Arrowmont's workshops, conferences, community classes, children's classes, Elderhostel classes and Artists-In-Schools program. "I was very excited about the teaching aspect of the program," she said. "It is a good balance for me because I can keep my connection with teaching children and still do my own artwork."

Another aspect of the Artists-in-Residence program is exhibition opportunities. In addition to the 1997-98 Artists-in-Residence Exhibition at Arrowmont, Johanna exhibited her work at Southern Virginia College. Oklahoma Beta Barbara Lyons Crawford, an Arrowmont board member, is a professor of art history at the college and invited Johanna and two other artists to exhibit their work. "It was rewarding to take our artwork to a finishing point and see it in a gallery setting," Johanna said.

The Artists-in-Residence program taught Johanna more than she expected. "When I came last summer, I really didn't know what to expect," she said. "At that time I was looking for an art education job and was scared I was going to get the teaching job and not have time for my own work. Now, after being a resident at Arrowmont, I know I have enough connection to my artwork that I'll keep doing it, even when



I get a full-time teaching position." Johanna has discussed volunteering for the Arrowmont Ambassador program with

Iowa Gamma Ann Struble Norris, an Arrowmont board member, and is excited to teach other Pi Phis about Arrowmont. "I've had such a great experience here, and I think that for art, or even non-art, students it is a great opportunity to come on spring break or over the summer." Johanna said.

Johanna hopes to someday teach at a college level and maintain a studio at home to pursue her printmaking. "That goal will not happen right away, so I'm sure I'll venture into lots of other things," she said. "As long as I can keep my artwork somewhere in my life, I'm happy with that."

# Collegiate News



## *Hang on to your hats!*

Pi Beta Phi collegians are at it again. Across the country our chapters are inventing creative activities to raise money for Arrowmont School of Arts and Crafts, donating books and tutoring children in the name of Links to Literacy and participating in dozens of other philanthropic activities. These Pi Phis are making a difference on their campuses and in their communities.

The **OREGON BETA** Chapter at Oregon State University sponsored *Dispelling the Myth*, a program that educates students about the dangers of alcohol and date rape. The university's Greek Life Department asked the chapter to expand the program campus-wide.

The **ONTARIO GAMMA** Chapter at the University of Guelph raised more than \$400 for the community food bank.

Twice each week, members of the **ARIZONA BETA** Chapter volunteer at the local soup kitchen to provide food and tutoring for adults and children. 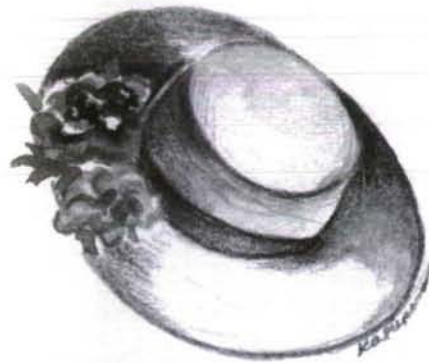

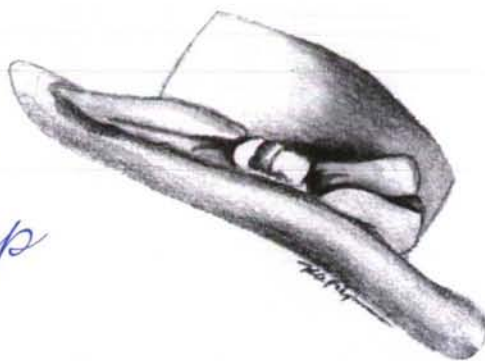

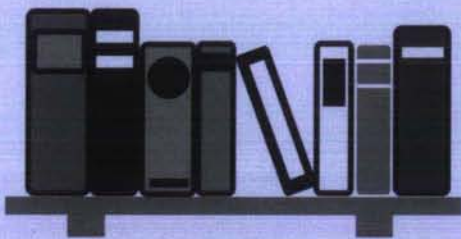

driving force behind revitalizing the city's image in the eyes of the community and the nation.

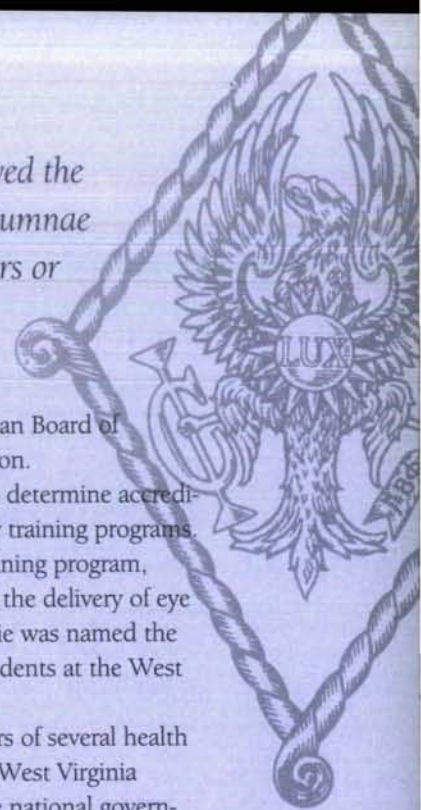

Arrow letters put off until due and then slighted; chapter correspondence sadly neglected and when the letters are finally hurried off, they are indeed poor realizations of our Fraternity ideals. Really, if our enemies could see some of the letters received by corresponding secretaries, what a stimulus would be given their side of the question.

Our Fraternity is either much or nothing. If it be much, no honest girl will lose one effort to make it more; if nothing then were it best to drop it. Let us give more time to our work, that is all the Fraternity needs, for no one wishes other for it than the best. Let us give more time to the forming of friendships which shall be harmonious and lasting. Thus will our Fraternity be a sweet refuge from the rush of school duties, and in it will be our ideal life, tranquil, noble, sacred.

### *Former consultants share their accomplishments*

They began as fresh-faced graduates, proud of their brand-new college degrees and litany of volunteer, campus and chapter activities. They were ready for anything—and that's just what they got. These outstanding women were asked to spend their first year between the comfort of college life and the mystery of the "real world" traveling across the country, serving as mentors, teachers, counselors, communicators and sometimes disciplinarians. It's all in a day's work for a Pi Beta Phi graduate consultant.

And when the year was over, they found that they not only survived the experience, but also picked up some pretty impressive skills along the way. In addition to building lasting friendships, they became expert negotiators, public speakers, delegators, diplomats and suitcase packers. They learned about time management, patience and themselves.

Now they are scattered across the country in places like Laramie, Wyoming; Boise, Idaho; Dallas, Texas; and Tampa, Florida. They are attorneys, elementary school teachers, nurses and marketing coordinators. But one thing unites the more than one hundred former Pi Beta Phi graduate consultants—each cherishes the year she spent as a consultant.

On the following pages former consultants recount their fond memories and pour out their appreciation for the opportunity to serve as a consultant. They say they gained much—friendships, job skills, self-confidence and networking to name a few. Read on to see how being a graduate consultant paves the way for a career as a host of a radio show, an attorney, a social worker, a community planner, a volunteer, a Greek adviser and a mother whose daughter is on the 1998–99 roster of graduate consultants. The Pi Beta Phi traveling graduate consultant program began in 1968 when Grand Council appointed Kansas Beta Martha Reynolds White as the first Traveling Graduate Counselor (now called Consultants). The first Resident Graduate Consultants were chosen in 1970 to live with new chapters or established chapters in need of advice and nurturing.

However, the custom of choosing outstanding collegiate women to help new colonies and chapters with special needs began in the mid-1950s. In 1958, Grand President Beth van Maanen Beatty served as one of the early resident consultants.

Over the years, the program has evolved. Yet, the job is much the same. One change is that the selection process is more stringent now. In the past, women were simply asked to be consultants by Fraternity officers. Now graduates undergo an extensive application and interview process. Consultants continue to provide support in the area of finances, rush, membership selection, risk management, chapter morale, officer training, academic programming and much more. And now, just like in the past, consultants promote Pi Beta Phi as a life-long commitment.
